CROWN ESTATE SCOTLAND / BIDWELLS UPDATE FOR WHAM

As those who were able to attend the WHAM AGM will be aware, Crown Estate Scotland (CES) were at that time evaluating tender submissions for the provision of Management Services for their various portfolios. We are pleased (and relieved!) to be able to confirm that Bidwells' submission for the management of the Coastal Estate was successful and we will be commencing work under the new contract from 1st April 2021.

From a customer perspective, this should mean that there is no change to the current service or personnel. Val will still be your first point of call so far as Association paperwork and agreements are concerned, whilst Rob (North), John (Clyde) and Tony (Argyll) will continue as the Community Marine Officers on the ground or water as appropriate. Our Regional Managers will also be staying the same, with Graeme Ferguson looking after Argyll, Alastair Campbell the North and Darren Hirst the South West. As always, please do contact a member of the team should you wish to discuss arrangements in your local area, a current or future project, or, indeed, any matters of general marine interest. If it's related to the marine environment, we'd be delighted to hear from you.

One question that we are already being asked by a number of Associations is whether or not the mooring fees are going to be increased for this season. We can confirm that no changes are planned for 2021 and we are currently operating on the same basis as in previous years in terms of declarations and payment dates. However, given the evolving nature of the pandemic and the Government's response to it, Crown Estate Scotland are keeping the situation and their Covid-19 policies under continual review and we'll be in touch if arrangements change.

Whilst events of last year meant that many boats remained ashore the signs for the 2021 season look to be more promising. Although many boatyards and marinas continue to be quiet at present, we are aware that preparations are already underway for what we all hope will be a relaxing of rules later in the spring and early summer. We have been advised by the Scottish Tourism Alliance that waterborne visitors from abroad are unlikely to materialise in significant numbers, but there is an expectation that domestic boat owners will be keen to swap one type of cabin fever for another! If that is the case, then there are a couple of recent developments which may be of interest to those who intend to venture forth this season:

- The Colonsay Community Development Company plans to install two trots of visitor moorings in Loch Staosnaig (aka Queens Bay), the next bay to the south of Scalasaig. This will allow visiting boats to avoid the fender-testing exercise of lying alongside the pier whilst still ensuring that those who wish to venture ashore for liquid refreshment do not have to face too much of a hike. Both David Vass and Tony have been working with the islanders to try and bring this about and whilst the final location is less than ideal, we have managed to protect the recognised anchorage and (hopefully!) avoid the power cable which crosses the northern part of the bay.
- Further north, Arisaig Marine recently changed hands and we have been working with the new owners to enable them to expand their operation. After discussions with the boatyard and WHAM we have agreed the location of both an expanded mooring area (to include larger visiting vessels) and a designated anchorage area. The new owners also have plans to install a sizeable landing pontoon that will tie in with the existing slipway and work is underway to bring this to fruition for the 2021 season.

Finally, routine work continues as much as current restrictions allow. The coastal team continue to make site visits where absolutely necessary but, like many others, have become more accustomed to attending meetings and Association AGMs online. As ever, please feel free to contact any of us if you require assistance or information and we will do our best to help.

GRANTS AVAILABLE

Two new grant pots were launched by Crown Estate Scotland last year.

Community Capacity Grants will provide early-stage financial support for community enterprise projects that contribute to local regeneration and sustainable development. The fund designed to help communities up to five miles from Scotland's coastline or within five miles of our rural estates. The fund is currently closed but should reopen again in May 2021. Environment Grants will provide funding to Crown Estate Scotland tenants for projects on the Scottish Crown Estate which can deliver demonstrable environmental benefits. Typical projects could include:

- Initiatives to increase local biodiversity;
- Making the local environment more attractive through, for example, planting and landscaping etc;
- Facilitating a change to greener ways of operating e.g. measures to support recycling or waste reduction; enabling green travel; activities that reduce flood risk, pollution or carbon emissions; and
- Materials providing information e.g. display boards about the local environment.

Projects which can demonstrate wider community benefits as well as environmental benefits are encouraged. In the first year £100,000 of funding is available, with individual grants of £5,000 - £20,000. Again, this grant fund is currently closed but should reopen again soon.
